 Guardian of my infant children during their minorities and do declare this to
 be my last Will and Testament and revoke all former Wills if any the witness
 whereof I have to this my Will contained in four sheets of paper set my hand
 this fifth day of January in the year of our Lord one thousand eight hundred
 and forty four - *John Sir Isaac* - signed published and declared by the said
 Testator Sir Isaac as and for his last Will and Testament in the presence
 of us at the same time when this procedure at his request and in the presence
 of each other have thereto subscribed our names as witnesses - *John
 Morris* *Henry Oxford* *St. Iwanoca* - *Nicholas* *Bliss* *Oxford* *St. Iwanoca*.

Proved at Douvrou 17th October 1854 before the Judge by the oath of Sir
 Isaac Sir Isaac the Brother the sole Executor to whom Honours was at
 granted having been first sworn by Commission duly to administer.

This is the last Will and Testament
 of me Elizabeth Mills of Cottermouta in the County of Cumberland single
 Woman I give devise and bequeath unto my Sister Sarah Mills all my
 real and personal estate whatsoever and wheresoever to hold to her at
 her heirs Executors and Administrators for ever and I appoint her the sole
 Executrix of this my Will the witness whereof I have thereto set my
 hand this twenty ninth day of March one thousand eight hundred and forty
 three - *Elizabeth Mills* - signed published and declared by the said
 Testatrix Elizabeth Mills as and for her last Will and Testament in the pres-
 ence of us when in her presence at her request and in the presence of each other
 have thereto subscribed our names as witnesses - *William* *William* -
Nelson *William*.

The Will of Elizabeth Mills late of Cottermouta in the County of Cumber-
 land Spinster deceased was proved at York the fifth day of June in the
 year of our Lord one thousand eight hundred and fifty four before the
 Reverend Edward Farwell Clerk in Charge of the Right Worshipful Great
 Will and Prerogative Court of York and I have thereto set my
 hand this fifth day of June in the year of our Lord one thousand eight hundred
 and fifty four and I have thereto subscribed my name as witness - *Wm. Hudson* *Wm. Buckell* *Equity Registrar*

Proved at Douvrou 18th October 1854 before the Judge by the oath of
 Sarah Mills Spinster the Sister the sole Executrix to whom Honours was
 granted having been first sworn by Commission duly to administer.

This is the last Will and Testament
 of me Mary Muddock of Sinters near Spa Road Bermondsey in the
 County of Surrey Widow I give devise and bequeath unto my
 just debts funeral and testamentary expenses I give and bequeath unto
 my daughter Ann Dorpa the wife of Giovanni Dorpa the sum of fifty
 pounds Sterling to be paid to her within three Calendar months after my
 decease to and for her own sole and separate use and benefit free from
 the debts control or engagements of her present or any future husband
 and her receipt alone notwithstanding her Coverture shall be a sufficient
 discharge to my Executor for the said legacy I give and bequeath unto
